(4) Confirmation of compliance

It is hereby declared that the above products supplied by us comply with the following legal provisions and recommendations in the current version as of the date of issue:

- Regulation (EC) No. 1935/2004 (framework regulation, food contact).
- Regulation (EC) No 10/2011 (Plastics Regulation)
- Regulation (EC) No. 2023/2006 (GMP, "good manufacturing practice").
- Directive 94/62/EC (packaging directive, ban on heavy metals).
- National legislation: BedGgstV, LFGB, BfR plastic recommendations (dyes, fillers).

(5) Overall migration and food contact conditions:

The test conditions for our studies correspond to the standard test conditions OM 2 according to the Plastics Regulation and apply to the following food contact conditions:

Any long-term storage at room temperature or below, including heating at 70°C for up to 2 hours or heating at 100°C for up to 15 minutes.

The simulators used apply to all types of food. The analyzes were repeated several times according to the conditions for reusable items. A surface/volume ratio of 6 dm3/kg is assumed.

(6) Substances with restrictions and/or specific migration limits (QM/SML)

The SML and/or QM values prescribed by the plastics regulation are met under the test conditions. With the exception of white colored products (TiO2), no additives are used for dual use. The products do not contain a functional barrier.

(7) Processing

The raw materials are processed into the above-mentioned products in accordance with the rules for good manufacturing practice (GMP) according to Regulation (EC) No. 2023/2006 based on recommendations from the Industrial Association for Semi-finished and Consumer Products Manufactured by Plastic e.V., Frankfurt.

(8) Application specification

Unless a different specification is agreed in writing, the contact conditions specified in paragraph (5) are considered permitted conditions of use. We recommend cleaning the products before they encounter contact with food to remove any contamination caused by handling, transport and storage.

(9) More information

This declaration of conformity supersedes all previously issued declarations of conformity and comparable certificates. The conformity of raw materials, colors and additives is checked through random sampling and screening methods. Migration studies do not take place for each individual product variant. These can be arranged against payment of costs.

To prove compliance, suitable documents (so-called "supporting documents") are kept available for submission to the responsible authorities. There is no legal obligation to disclose these documents. We ask for your understanding that we generally do not do this to protect our know-how (processes, recipes, sources of supply, etc.).
