

Product Description

3M[™] 94-EE 995-6 xx MC 630A and 1250A Separable Connectors consist of an Asymmetrical T Type Separable Connector. The assembly is safe to touch and has an integrated stress controlling part. Each kit contains all the necessary components to install three Plug-In Terminations, including a mechanical connector.

Application

3M[™] 94-EE 995-6 xx MC 630A and 1250A Separable Connectors are designed to be installed on wire screened non-armoured polymeric insulated cables for 19/33(36)kV - 630A and 1250A applications. The Separable Connector establishes the connection between any polymeric insulated cable onto transformers, switchgears, motors or other equipment.

Typical Properties

The one-piece design of the Separable Connector is made of EPDM rubber. It guarantees a watertight connection and a long life span for cable ends. It is suitable for outer cone bushings according to DIN EN 50180 and DIN EN 50181.
