Confirmation for European Community Directive 1907/2006/EC (REACH)

Dear Customer,

You are purchasing exclusively electrical or electromechanical, non-chemical products from Belden Deutschland GmbH. With these products we are, in terms of REACH (1907/2006/EC), a so-called "downstream" user. We are therefore neither subject to mandatory registration, nor obliged to compile safety data sheets. Products purchased by you ought not to release substances under normal intended use.

Our products do not contain residual hazardous substances originating from our production process. In consideration of the mandatory candidate list (16th January 2020) with 205 substances and the information from our suppliers we can, with the exception of lead (CAS no 7439-92-1), exclude the existing of a SVHC (Substances of Very High Concern) in a concentration above 0.1 % weight by weight in our articles. If this should be the case in the future, we will naturally provide information, in accordance with our obligations according to §33 of the REACH regulations, about the existence of the substances concerned.

The above named lead is in the copper alloy of our contact elements in a proportion of 3% in the homogeneous material. Not affected are the articles of the RJ45 series and all articles which do not contain contacts (e.g., gaskets).

Likewise, our articles (including packaging) comply with their ingredients the requirements of Annex XVII.
